$1^{\text {st }}$ quarter of 2018

## The unemployment rate was 7.9\%

The unemployment rate for the $1^{\text {st }}$ quarter of 2018 was $7.9 \%$. This value is down 0.2 percentage points (p.p.) from the previous quarter and 2.2 p.p. from the same quarter of 2017.

The unemployed population, estimated at 410.1 thousand people, decreased by $2.8 \%$ (11.9 thousand fewer people) from the previous quarter, extending the quarterly decreases observed since the $2^{\text {nd }}$ quarter of 2016. Comparing to the year-on-year value, there was a decrease of $21.7 \%$ ( 113.8 thousand fewer people), slightly smaller than the one observed in the previous quarter.

The employed population, estimated at 4,806.7 thousand people, recorded a practically null relative change (associated to a small increase of 1.8 thousand people) and a year-on-year growth of 3.2\% (148.6 thousand more people)

The youth (15 to 24 years old) unemployment rate was $21.9 \%$, the lowest value of the data series started in the $1^{\text {st }}$ quarter of 2011.

The labour underutilisation rate was $15.2 \%$. This figure is 0.3 p.p. lower than in the previous quarter and 3.0 p.p. lower than in the same quarter of 2017.

In these estimates, the population aged 15 and over was considered and the values are not seasonally adjusted.

## 1. Labour force (active population)

The Labour Force Survey results for the $1^{\text {st }}$ quarter of 2018 indicate that the labour force (active population), estimated at 5,216.8 thousand people, decreased by $0.2 \%$ from the previous quarter ( 10.1 thousand) and increased by $0.7 \%$ from the same quarter of 2017 (34.8 thousand).

The participation rate of the working age population (15 years old and over) stood at 58.9\%, having decreased by 0.1 percentage points (p.p.) from the previous quarter and increased by 0.4 p.p. from the same quarter of 2017.

The participation rate of men (64.4\%) was 10.2 p.p. higher than that of women (54.2\%). Compared to the
previous quarter, the participation rate decreased for men (0.3 p.p.) and increased for women (0.1 p.p.).

On the other hand, regarding the year-on-year comparison, both participation rates increased, the increase for women ( 0.5 p.p.) being larger than the one observed for men (0.4 p.p.).

## 2. Employed population

### 2.1. Quarterly changes

The employed population, estimated at 4,806.7 thousand people, increased by 1.8 thousand people, corresponding to a practically null relative change.

This quarterly change of the employed population was explained by the increases recorded mainly in the following groups: women ( 9.2 thousand; 0,4\%); people aged 45 to 64 (12.9 thousand; 0.6\%); having completed the upper secondary and post-secondary non-tertiary education (29.0 thousand; 2.3\%); employed in the services sector (34.2 thousand; 1.0\%), having the employment in the activities of wholesale and retail trade, repair of motor vehicles and motorcycles, of transportation and storage, and of accommodation and food services contributed for more than half of this increase ( 18.4 thousand; 1.5\%); as self-employed workers (1.9 thousand; 0.2\%); and working full-time (16.6 thousand; 0.4\%).

The employment rate (15 years old and over) stood at $54.3 \%$, remaining unchanged from the previous quarter.

The employment rate of men (59.5\%) exceeded that of women (49.8\%) by 9.7 p.p., having the former decreased by 0.2 p.p. from the previous quarter while the latter increased by 0.2 p.p..

The employment rate ( 15 years old and over) increased by 1.7 p.p. from the same quarter of 2016, the same for both men and women.

## 3. Unemployed population

### 3.1. Quarterly changes

The unemployed population, estimated at 410.1 thousand people, decreased by $2.8 \%$ from the previous quarter (11.9 thousand), extending the quarterly decreases observed since the $2^{\text {nd }}$ quarter of 2016.

The unemployed population quarterly decrease was explained by the decreases recorded, mainly, in the following groups under analysis: women ( 8.7 thousand; 4.0\%); people aged 15 to 24 ( 9.6 thousand; 10.8\%); having completed, at most, the first or second stages of basic education ( 13.0 thousand; $6.2 \%$ ); looking for a first job ( 8.7 thousand; 15.9\%), having been formerly in the manufacturing, electricity, gas and water supply and construction sector (6.0 thousand; 6.8\%); and
seeking a job for 12 months or longer ( 7.5 thousand; 3.3\%).

The unemployment rate for the $1^{\text {st }}$ quarter of 2018 stood at $7.9 \%{ }^{1}$, having decreased by 0.2 p.p. from the $4^{\text {th }}$ quarter of 2017 and continued the quarterly decreases observed since the $2^{\text {nd }}$ quarter of 2016.

The unemployment rate of men ( $7.6 \%$ ) was lower than that of women ( $8.1 \%$ ) by 0.5 p.p., having the former decreased by 0.1 p.p. from the previous quarter and the latter decreased by 0.3 p.p..

On the other hand, the youth ( 15 to 24 years old) unemployment rate was $21.9 \%$, the lowest value of the data series started in the $1^{\text {st }}$ quarter of 2011. From the previous quarter that rate was down 1.6 p.p..

The share of unemployed people looking for a job for 12 months or longer (long-term unemployment) was $53.8 \%$, down 0.3 p.p. from the $4^{\text {th }}$ quarter of 2017.

### 3.2. Year-on-year changes

From the same quarter of 2017, the unemployed population decreased by $21.7 \%$ (113.8 thousand), a decrease slightly smaller than the one observed in the previous quarter.

The unemployed population year-on-year decrease was explained by the decreases recorded in the following groups: both men and women, especially the latter (58.6 thousand; 22.1\%); all age groups under analysis, in particular that of those aged 45 and over (50.2 thousand; 25.1\%); with different levels of education, mainly those having completed, at most, the first or second stages of basic education (78.1 thousand; 28.3\%); mostly looking for a new job (105.1 thousand; 22.4\%), having been formerly in the services sector ( 59.9 thousand; 19.9\%); and seeking a job mainly for 12 months or longer (88.1 thousand; 28.5\%).


The unemployment rate decreased from the same quarter of 2017 (2.2 p.p.), more for women (2.4 p.p.) than for men ( 2.2 p.p.).

The unemployment rate of young people aged 15 to 24 decreased by 3.2 p.p. from the year-on-year value.

From the $1^{\text {st }}$ quarter of 2017, the share of unemployed people looking for a job for 12 months or longer (long-term unemployment) decreased by 1.8 p.p..

## 4. Inactive population

The inactive population, estimated at $5,054.0$ thousand people in the $1^{\text {st }}$ quarter of 2018 , increased by $0.1 \%$ from the previous quarter ( 2.8 thousand) and decreased by $1.1 \%$ from the same quarter of 2017 (58.0 thousand).

The inactive population aged 15 and over, estimated at $3,634.4$ thousand people ( $71.9 \%$ of total inactive population), increased by $0.3 \%$ from the previous quarter ( 9.4 thousand) and decreased by $1.1 \%$ from the $1^{\text {st }}$ quarter of 2017 ( 38.8 thousand).

The inactivity rate (15 years old and over) stood at $41.1 \%$, having increased by 0.1 p.p. from the previous quarter and decreased by 0.4 p.p. from the same period of 2017.

The inactivity rate of women (45.8\%) exceeded that of men (35.6\%) by 10.2 p.p..

From the previous quarter, the inactivity rate of men increased by 0.3 p.p. and that of women decreased by 0.1 p.p.. When compared to the same quarter of 2017, the inactivity rate of men decreased by 0.4 p.p., less than that of women ( 0.5 p.p.).

Figure 7 exhibits a summary of the observed changes in this quarter (year-on-year and quarterly) by labour market status, as described in items 1 to 4 of this Press Release.


## 5. Quarterly flows between labour market states

### 5.1. Gross and net flows (number of persons)

## Employment

From the $4^{\text {th }}$ quarter of 2017 to the $1^{\text {st }}$ quarter of 2018, the number of persons that moved from employment (E) to unemployment (U) was 85.7 thousand and the number of those who moved from employment to inactivity (aged 15 and over; I) was 147.6 thousand. The number of persons moving out of employment, within a quarter, was 233.3 thousand.


At the same time, the employment inflows from unemployment were 99.2 thousand persons, while those from inactivity were 135.9 thousand. The number of persons moving into employment, within a quarter, was 235.1 thousand.

As a consequence, between the two quarters there was a positive net flow into employment (that is, total inflows minus total outflows) of 1.8 thousand persons

(which correspond to the employed population quarterly change).

## Unemployment

The net flow into unemployment was also negative and comprised 11.9 thousand persons (which corresponds to the unemployed population quarterly change), and resulted from the total of people becoming unemployed (169.7 thousand) being smaller than the total of those leaving the unemployment status (181.6 thousand).

The unemployment inflows from employment ( 85.7 thousand) were higher than those from inactivity (84.0 thousand), while the unemployment outflows to employment (99.2 thousand) were larger than those to inactivity ( 82.4 thousand).

The next figures exhibit the quarterly developments of the net employment and unemployment flows, from the $2^{\text {nd }}$ quarter of 2011 onwards, and their decomposition into the two components that explain them: net flows between employment and unemployment and net flows between employment and inactivity (Figure 8); net flows between unemployment and employment and net flows between unemployment and inactivity (Figure 9).



From these estimates analysis, it is possible to conclude, for the $1^{\text {st }}$ quarter 2018, that:

- The small employment quarterly increase resulted from the positive net flow between employment and unemployment being slightly larger than the negative net flow between employment and inactivity (13.5 thousand and 11.7 thousand, respectively).
- The unemployment quarterly decrease, of 11.9 thousand persons, was mainly explained by the negative net flow between unemployment and

employment (13.5 thousand), which more than compensated the slightly positive net flow between unemployment and inactivity (1.7 thousand).

### 5.2. Transition rates (\%)

From the $4^{\text {th }}$ quarter of 2017 to the $1^{\text {st }}$ quarter of 2018, $1.8 \%$ of the people initially employed moved into unemployment and $3.1 \%$ moved into inactivity, with the proportion of employed moving out of this situation totalling $4.9 \%$ in the $1^{\text {st }}$ quarter of 2018 ( $95.1 \%$ remained employed; which corresponds to 4,571.6 thousand people, as in Diagram 1).

From the total of unemployed persons in the $4^{\text {th }}$ quarter of $2017,43.0 \%$ moved out of this labour market state in the $1^{\text {st }}$ quarter of 2018: $23.5 \%$ became employed and $19.5 \%$ moved into inactivity.

From the total of people aged 15 and over considered to be inactive in the $4^{\text {th }}$ quarter of $2017,3.7 \%$ moved into employment and $2.3 \%$ moved into unemployment in the $1^{\text {st }}$ quarter of 2018.

## 6. Unemployment rates by NUTS II region

In the $1^{\text {st }}$ quarter of 2018 , the unemployment rate was higher than the national average in four NUTS II regions of the country: Região Autónoma da Madeira (9.1\%), Região Autónoma dos Açores (8.9\%), Área Metropolitana de Lisboa (8.6\%), and Norte (8.1\%).

Below the national average, stood the unemployment rate of Alentejo (7.8\%), Algarve (7.6\%), and Centro (6.3\%).

Compared to the previous quarter, as has been globally observed for Portugal, the unemployment rate decreased in Alentejo (0.6 p.p.) and Norte (1.2 p.p.), having increased in the remaining five regions of the country: Região Autónoma dos Açores (0.6 p.p.), Centro and Área Metropolitana de Lisboa (0.4 p.p. in both of them), Algarve ( 0.3 p.p.), and Região Autónoma da Madeira (0.2 p.p.).

Compared to the same quarter of 2017, and also similarly to the overall picture in Portugal, the unemployment rate decreased in all regions.

The two largest decreases were recorded in Região Autónoma da Madeira (3.4 p.p.) and Algarve (3.0 p.p.).

## 7. Supplementary indicators to unemployment and the labour underutilisation

The labour underutilisation is an indicator that aggregates the unemployed population, the underemployment of part-time workers, the inactive seeking work but not immediately available, and the inactive available but not seeking work ${ }^{2}$. This indicator is supplemented by its corresponding rate - the labour underutilisation rate ${ }^{3}$.

With this indicator, Statistics Portugal provides its data users a broader measure of the labour underutilisation than the more restrictive measure given by the unemployment rate, without changing the method of calculus and the official estimate status of the latter.

Nonetheless, while analysing that indicator ${ }^{4}$ it is necessary to have in mind that it is a measure that overestimates the labour underutilisation, since:

- it overestimates the potential contribution from the underemployed part-time workers, as it does not take into account the hours worked by these employed persons (typically, the hours worked correspond to half of the desired total hours);

[^1]- it overestimates the extended labour force because the two included inactive population subgroups have, in general, a lower attachment to the labour market than the unemployed population. This results from the existence of a lower probability of transition to the labour force, a larger share of people that have never worked or that have stopped working more than 2 years ago, and a smaller share of people that self-define themselves as unemployed ${ }^{5}$.

In the $1^{\text {st }}$ quarter of 2018, the underutilised population was estimated at 825.9 thousand people and the corresponding rate was $15.2 \%$.

Comparing to the previous quarter, the labour underutilisation decreased by $2.2 \%$ ( 18.5 thousand), less than when comparing to the previous year ( $16.2 \%$; 160.2 thousand). By component, the following is observed:

- The unemployed population was estimated at 410.1 thousand people, as previously mentioned,

having decreased by 2.8\% (11.9 thousand) from the previous quarter and by $21.7 \%$ (113.8 thousand) from the same quarter of 2017. The unemployment rate stood at $7.9 \%$, down by 0.2 p.p. from the previous quarter and by 2.2 p.p. from the $1^{\text {st }}$ quarter of 2017.

- The number of underemployed part-time workers, estimated at 199.4 thousand, remained practically unchanged from the previous quarter and decreased by 8.9 \% (19.5 thousand) from the same quarter of 2017.
- The number of inactive persons seeking work but not immediately available, estimated at 16.8 thousand, decreased by 19.4\% (4.1 thousand) from the $4^{\text {th }}$ quarter of 2017 and by $30.4 \%$ (7.4 thousand) from the $1^{\text {st }}$ quarter of 2017.
- The number of inactive persons available to work but not seeking, estimated at 199.6 thousand, decreased by $0.9 \%$ ( 1.7 thousand) from the previous quarter and by $8.9 \%$ (19.5 thousand) from one year before.

The unemployed population and the labour underutilisation have displayed a downwards trend since the $1^{\text {st }}$ quarter of 2013, having decreased in total $55.8 \%$ and $43.8 \%$, respectively (corresponding to 516.7 thousand and 643.7 thousand people in each case). These reductions were also observed in the correspondent rates, having the unemployment rate dropped from $17.5 \%$ to $7.9 \%$ and the labour underutilisation rate from $26.4 \%$ to $15.2 \%$.


## 8. Young people not in employment, education or

 trainingIn the $1^{\text {st }}$ quarter of 2018, from the total of 2,222.3 thousand young people (aged 15 to 34), 10.5\% (234.1 thousand) were not in employment, education or training.

In the quarter under analysis, this group was composed, mainly, of men (51.0\%; 119.3 thousand), people aged 25 to 34 (59.6\%; 139.6 thousand), having completed, at most, the first or second stages of basic education (42.7\%; 99.9 thousand) or the upper secondary and post-secondary non-tertiary education ( $42.2 \%$; 98.8 thousand), and unemployed (58.2\%; 136.2 thousand).

From the previous quarter, the rate of young people not in employment, education or training remained unchanged.

In terms of population groups, it was observed an increase in men ( 5.8 thousand; 0.5 p.p.) and a decrease of similar dimension in women ( 5.5 thousand;

0.4 p.p.). Similarly, it was verified an increase in the age group of those aged 25 to 34 (4.5 thousand; 0.4 p.p.) and a decrease in the other two groups, of those aged 15 to 19 ( 2.5 thousand; 0.4 p.p.) and of 20 to 24 (1.9 thousand; 0.4 p.p.). Also in the education levels there was an increase in the group of those having completed the upper secondary and post-secondary non-tertiary education (11.1 thousand; 1.2 p.p.) and a decrease among those having completed, at most, the first or second stages of basic education (6.9 thousand; 0.8 p.p.) or the tertiary education (4.1 thousand; 0.6 p.p.).


From the $1^{\text {st }}$ quarter of 2017 , the share of young people (aged 15 to 34) that were not in employment, education or training decreased by 1.3 p.p. (31.4 thousand).

This year-on-year decrease resulted, mainly, from the decline in the number of women not in employment, education or training (1.9 p.p.; 23.6 thousand) and was larger for those aged 25 to 34 (2.0 p.p.; 26.6 thousand), as well as among those having completed, at most, the first or second stages of basic education (1.6 p.p.; 19.7 thousand).

## TECHNICAL NOTE

The main purpose of the Labour Force Survey is to characterise the population in terms of the labour market. It is a quarterly sample survey, addressed to families occupying the same dwelling in the national territory, which makes available quarterly and annual data.
Most of the characteristics observed in this survey report to the situation in one pre-defined week (from Monday to Sunday), known as reference week. The reference weeks are uniformly distributed throughout the quarters and years. The interviews usually take place in the week following the reference week.
The information is obtained directly, through computer-assisted interview, by using a mixed data collection mode: the initial interview is done face-to-face by an interviewer visiting the household and the other five interviews are done by telephone, if certain requirements are met.
Published data were calibrated by using the population estimates calculated from the final results of Census 2011. Due to rounding, the totals in tables and diagrams do not always match the sum of parts.

## Some concepts

Unemployed: person aged 15 and 74 who, during the reference period, was simultaneously in the following situations:

- without work, i.e. was not in paid employment or self-employment;
- seeking work, i.e. had taken specific steps in a specified recent period (reference period or the three previous weeks) to seek paid employment or self-employment; and
- currently available for work, i.e. was available for paid employment or self-employment during the reference period.

Employed: person aged 15 and over who, during the reference period, was in one of the following situations:

- did any work for pay or profit for at least one hour, including a familiar gain in money or gender;
- was not working but had jobs from which was temporarily absent;
- had a business, but was temporarily not working for a specific reason;
- was in a pre-retirement situation while working.

Labour force (active population): all persons aged 15 or over who, during the reference period, made up the available labour force for the production of economic goods and services (employed and unemployed).

Extended labour force: labour force enlarged by the inactive seeking work but not immediately available and the inactive available but not seeking work.
Labour underutilisation: indicator that aggregates the unemployed population, the underemployment of part-time workers, the inactive seeking work but not immediately available, and the inactive available but not seeking work.
Young people not in employment, education or training: population of young people of a given age group that, in the reference period, was not employed (i.e., was unemployed or inactive) and was not involved in education or training over a specific period of time (the reference week or in the previous three weeks).
Participation rate: ratio between the labour force and the total population.
P.R. (\%) = (Labour force $/$ Total population) $\times 100$

Participation rate ( $\mathbf{1 5}$ and over): ratio between the labour force and the working age total population ( 15 and over).
P.R. (\%) $=($ Labour force $/$ Total population 15 and over $) \times 100$

Employment rate ( $\mathbf{1 5}$ and over): ratio between the employed population and the working age total population (15 and over).
E.R. $(\%)=($ Employed population $/$ Total population 15 and over $) \times 100$

Unemployment rate: ratio between the unemployed population and the labour force.
U.R. (\%) $=$ (Unemployed population $/$ Labour force) $\times 100$

Long term unemployment rate: ratio between the unemployed population seeking employment for 12 months and over and the labour force.
L.T.U.R. (\%) = (Unemployed population seeking employment for 12 months and over / Labour force) $\times 100$

Inactivity rate (15 and over): ratio between the working age inactive population (15 and over) and the working age total population (15 and over).
I.R. (\%) = (Inactive population 15 and over / Total population 15 and over) $\times 100$

Labour underutilisation rate: ratio that defines the relationship among the labour underutilisation and the extended labour force.
L.U.R. (\%) = (Labour underutilisation / Extended labour force) $\times 100$

Rate of young people not in employment, education or training: ratio between the population of young people of a given age group not in employment, education or training and the total population of young people of the same age group.

## On year rate of change

The in year (year-on-year) change compares the level of the variable in the current quarter with that of the corresponding quarter of the previous year. This rate of change, considering a seasonal stable pattern is not affected by this type of fluctuation, but may, however, be influenced by specific effects in a given quarter.

## On quarter rate of change

The in quarter (quarterly) change compares the level of the variable over two consecutive periods. Although this indicator permits to monitor the recent pace of the variable, its calculation is particularly influenced by seasonal effects and other more specific effects in one (or both) quarters under comparison.

## Annual rate of change

The annual change compares the average level of the variable for the four quarters of the last year over the average level of the variable for the four quarters of the previous year. Being an average, this indicator is less sensible to sporadic effects in the variable.
