October 2020 – Flash estimate

TOURIST ACTIVITY INCREASES REDUCTIONS IN OCTOBER

According to the flash estimate, in October 2020, the tourist accommodation sector¹ should have registered 1.0 million guests and 2.4 million overnight stays, corresponding to year-on-year rates of change² of -59.3% and -63.0%, respectively (-52.7% and -53.4% in September, in the same order). Overnight stays of residents will have decreased by 21.0% (-8.5% in September) and those of non-residents will have fallen by 76.2% (-71.9% in the previous month).

In October, 29.9% of tourist accommodation establishments would have been closed or did not received guests (24.0% in September).

Despite the circumstances determined by the COVID-19 pandemic, Statistics Portugal calls for the best collaboration by companies, families and public entities in responding to Statistics Portugal's data requests. The quality of official statistics, particularly its ability to identify the impacts of the COVID-19 pandemic, crucially depends on this collaboration, which Statistics Portugal thanks in advance.

In October 2020, **tourist accommodation sector** should have registered 1.0 million guests and 2.4 million overnight stays, corresponding to year-on-year rates of change of -59.3% and -63.0%, respectively (-52.7% and -53.4% in September, in the same order).

Overnight stays from residents will have decreased by 21.0% (-8.5% in September) reaching 1.2 million, corresponding to 51.1% of the total, while those from non-residents will have fallen by 76.2% (-71.9% in the previous month), standing at 1.2 million. Resident guests would have been 647.0 thousand, corresponding to a decrease of 23.9% (-15.4% in September) and non-resident guests would have reached a total of 371.8 thousand, decreasing by 77.5% (-73.8 % in the previous month).

Alentejo region will have continued to present the smallest decrease in the number of overnight stays, compared to the same month last year, decreasing by 29.8% (-20.9% in the previous month). The emphasis

goes to the growth in overnight stays of residents in the Algarve (+4.0%), which may have been related to a sports event this month in the region.

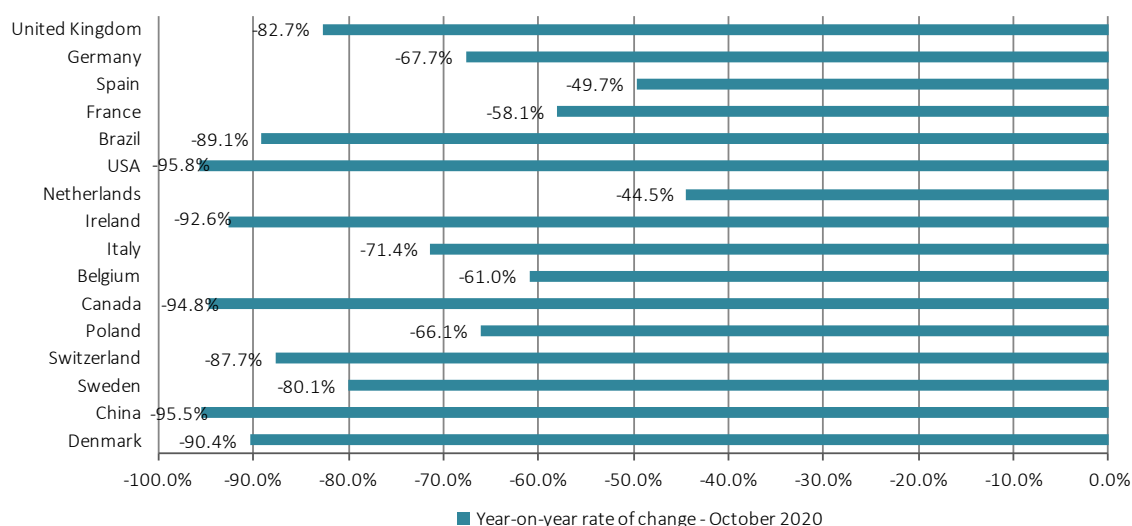
Figure 1. Year-on-year rates of change of overnight stays in tourist accommodation establishments, by region

EXPLANATORY NOTES

The sources used in this press release are: Survey on guest stays in hotel establishments and other accommodations.

The results presented may be revised, since the primary information has not yet been fully collected. The revisions that occurred with the publication of subsequent results have not been significant. The results involving greater detail will be published on December 17.

Guest – Individual that spends at least one overnight stay in a tourist accommodation activity establishment.

Overnight stay – Time spent by an individual between midday and midday of the following day.

Year-on-year rates of change – comparison between the variable level in the reference period and the same period of the year before. The calculation of year-on-year rates of change for the main indicators is based on values in units, although in this press release they are visible only in thousands.

In order to simplify the language, the term “foreigner” might be used instead of “non-resident”.
