### Consumer Price Index

## February – Flash estimate

## CPI annual rate of change estimated at 0.5%

Based on the information made available until the date of the present press release, the Consumer Price Index (CPI) annual rate is estimated to be 0.5% in February 2021, 0.2 percentage points (p.p.) higher than in January. The core inflation index, which excludes energy and unprocessed food products components, was 0.7% (0.6% in January). The annual rate of change of the index for energy products is estimated to be -3.1% (-4.4% in the previous month) and the estimated rate for unprocessed food is 1.4% (1.7% in January).

The estimated CPI monthly rate was -0.5% (in January, the final value was -0.3% and -0.6% in February 2020), while the CPI 12-month average rate was estimated to be nil (-0,1% in the previous month).

The estimate of the Portuguese Harmonised Index of Consumer Prices (HICP) annual rate of change was 0.3% (0.2% in the previous month).

The February CPI final results will be released on March 10<sup>th</sup>, 2021.

Despite the circumstances determined by the pandemic COVID-19, Statistics Portugal calls for the best collaboration by companies, families and public entities in responding to Statistics Portugal's data requests. The quality of official statistics, particularly its ability to identify the impacts of the pandemic COVID-19, crucially depends on this collaboration, which Statistics Portugal thanks in advance.

#### **Consumer Price Index**

The Consumer Price Index (CPI) measures the change over time of the prices of a certain basket of goods and services bought by a "typical" consumer. The CPI has been designed to capture price changes and not to measure price levels.

### Core inflation index (all items CPI excluding unprocessed food and energy products)

The core inflation index is compiled by excluding the prices of unprocessed food and energy products from the all items CPI. The primary objective of this index is to capture the underlying inflation pressures in the economy.

## Presentation of data and rounding rules

Indices are published with base 100 in 2012 since the release of the January 2013 CPI.

Due to rounding procedures, those indices may not reproduce exactly the published rates of change. However, it should be noted that the published rates prevail.

In this press release the descriptive analysis is based on rounded values to one decimal.

### **CPI/HICP flash estimate**

Statistics Portugal publishes a CPI/HICP flash estimate based on provisional data and price estimates.

This publication presents estimates for the annual and monthly rates of change of those indices, following a long period of compilation and internal evaluation of their quality compared to the published final figures. Additional details can be found in the January 2018 flash estimate press release.

In line with the dissemination practices followed by Eurostat and some EU countries this information will be disseminated on the last working day of each month.

# Changes in CPI/HICP weights for 2021

The expenditure shares of the CPI/HICP for 2021 had relevant changes in a few categories reflecting the use of preliminary data from the National Accounts in line with Eurostat's recommendations. These recommendations were determined by the need to incorporate the changes in the structure of final consumption expenditure of households observed in 2020 due to the impact of the COVID-19 pandemic.
