## Year-On-Year rate of industrial new orders remains negative

In the quarter ended in August 2009, new orders in industry year-on-year decreased 26.4% in nominal terms the (-26.2% in July), mainly due to the negative performance of external market (-31.0% in August, -29.1% in July).
